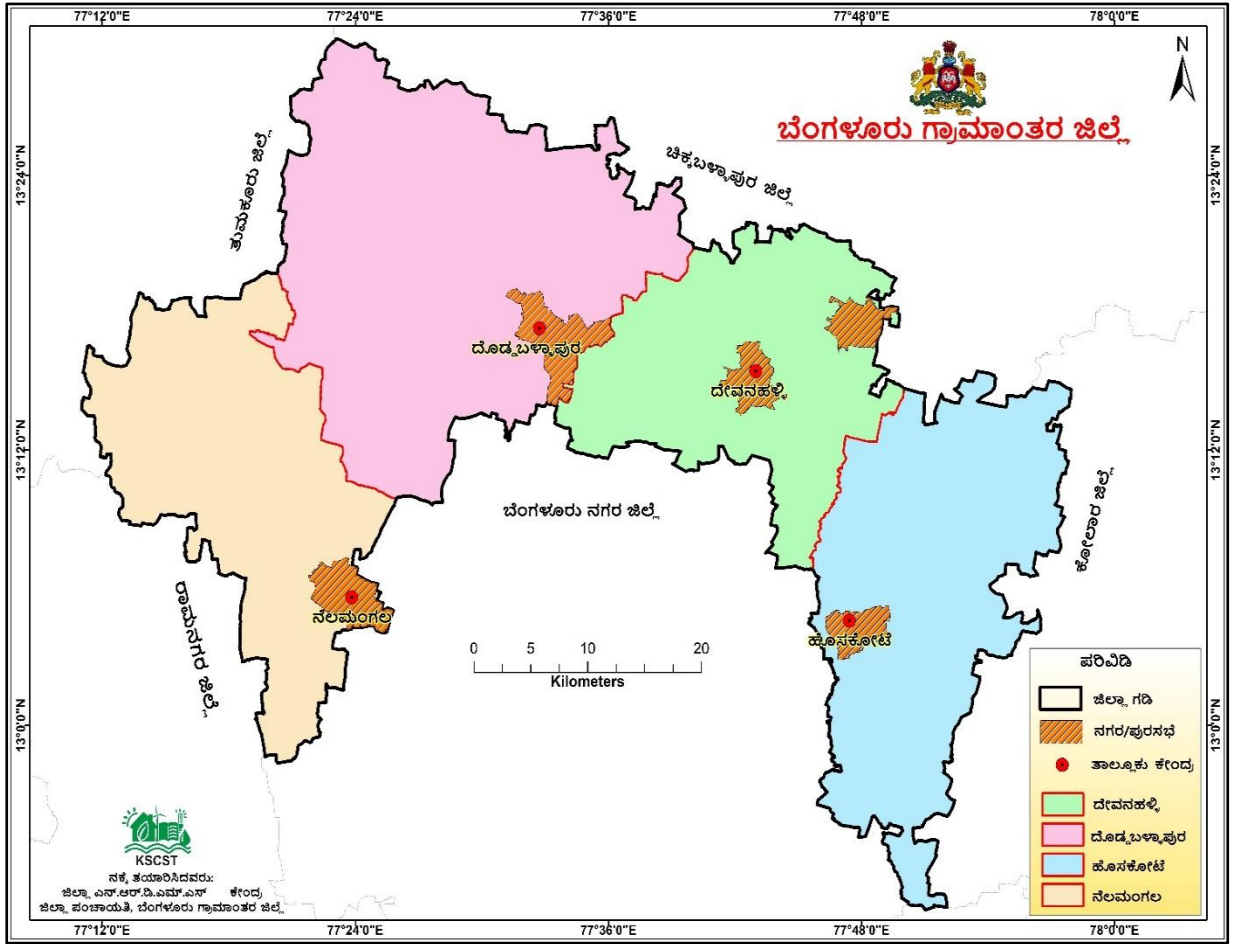

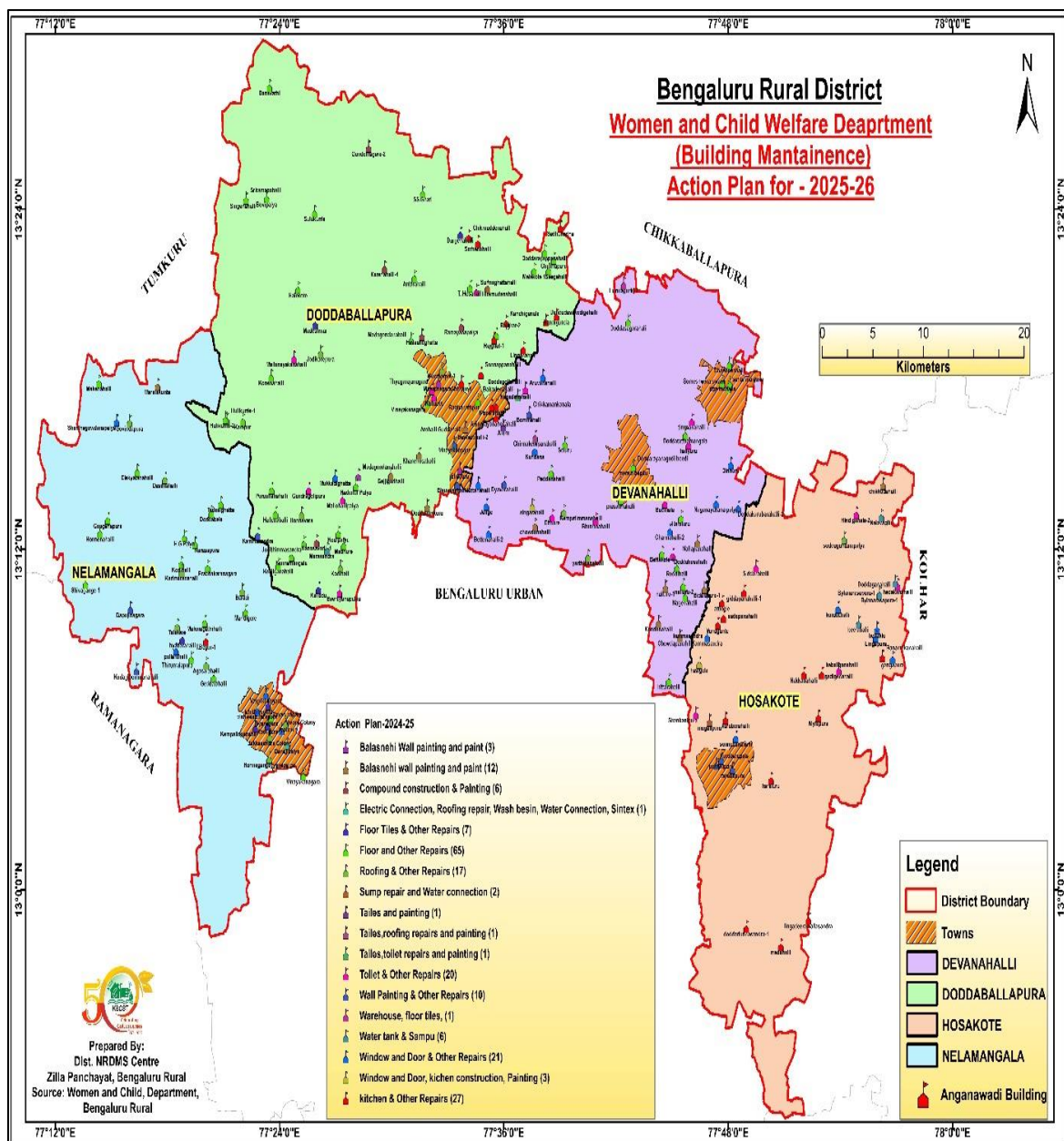

➤ **Preparation of Geo-Spatial Action Plan-2025-2026 Maps to Planning Section.:** The Geo-Spatial Action Plan (2025–2026) map for the Health and Family Welfare Department of Bengaluru Rural District was prepared to support planning, monitoring, and implementation of building maintenance activities. The map depicts the district boundary along with taluk-wise divisions—Devanahalli, Doddaballapura, Hoskote, and Nelamangala—clearly highlighting health facilities and proposed maintenance works spatially. It integrates administrative boundaries, location of facilities, and action plan details in a single visual framework, enabling the Planning Section to identify priority areas, assess spatial distribution of interventions, and support informed, data-driven decision-making.





The Geo-Spatial Action Plan (2025–2026) map prepared for the Women and Child Welfare Department, Bengaluru Rural District, supports planning and monitoring of building maintenance activities across the district. The map shows taluk-wise administrative boundaries—Devanahalli, Doddaballapura, Hoskote, and Nelamangala—and spatially locates Anganwadi buildings along with proposed maintenance works. By integrating facility locations, administrative units, and action plan details, the map helps the Planning Section identify priority areas, assess coverage and gaps, and enable informed, data-driven decision-making for effective implementation during 2025–2026.
