#### VACANCY CIRCULAR

#### Sub: Filling up of the post of "Scientific Officer" on deputation basis

The Karnataka State Council for Science and Technology (KSCST) is an Autonomous S&T organization under the Department of Science and Technology, Government of Karnataka located in the campus of Indian Institute of Science (IISc), actively engaged to identify problems / areas for the application of Science and Technology and to find scientific / technological solutions for the benefit of society at large.

- 1. It is proposed to fill up the vacant post of Scientific Officer in KSCST as indicated in Annexure-1 on deputation basis from amongst the eligible officers working in Central and State Government/Central and State PSUs/Central and State Autonomous/Statutory bodies/Universities established under the law.
- 2. Pay, allowances and service conditions of the officials selected on deputation will be governed by the provisions of the Cadre, Recruitment and Service Rules of KSCST & KCSR. Since KSCST has no residential facility, HRA as applicable to State Government/Central Government employee at Bangalore will be admissible.
- 3. Selected candidate will be appointed on deputation basis initially for a period of two (02) years, which may be extended on mutual consent up to a maximum period of five years, subject to satisfactory performance and review.
- 4. Absorption of the official can be considered either within a period two years or earlier of working on deputation on the post held by him/her subject to satisfactory performance of the official, acceptance of employee and submission of NOC from the parent organisation.
- 5. It is requested that wide publicity may be given to the vacancy circular amongst the staff working under your administrative control. A applications in the prescribed format (Annexure-2) along with attested copies of CRs of the officers for the last five years, who can be spared in the event of selection, may be sent to this office on or before 06-06-2025 at 5.30 PM. Applications received after the last date or without CR dossiers, vigilance clearance and integrity certificate or otherwise found incomplete will not be considered. While forwarding the applications, it may also be verified and certified that the particulars furnished by the applicants are correct and no disciplinary proceedings are either pending or contemplated against him/her.
